Prayer of the Jubilee Year of Mercy

December 8, 2015 to November 20, 2016

Lord Jesus Christ,

You have taught us to be merciful like the heavenly Father, and have told us that whoever sees you sees Him. Show us your face and we will be saved. Your loving gaze freed Zacchaeus and Matthew from being enslaved by money; the adulteress and Magdalene from seeking happiness only in created things; made Peter weep after his betrayal, and assured Paradise to the repentant thief. Let us hear, as if addressed to each one of us, the words that you spoke to the Samaritan woman: "If you knew the gift of God!"

You are the visible face of the invisible Father, of the God who manifests his power above all by forgiveness and mercy: let the Church be your visible face in the world, its Lord risen and glorified. Bishop Nelson Pérez was born in Miami, Florida in 1961. He grew up

and was educated in West New York, New Jersey, and graduated from Montclair State College. He was ordained to the priesthood on May 20, 1989. Early in his priesthood, Father Pérez developed a strong background in counseling and pastoral ministry. From 1990-1993 he served as Assistant Director of the Archdiocese of Philadelphia's Office of Hispanic Catholics. He then became the Founding Director of Philadelphia's Catholic Institute for Evangelization, and served in this role for the next nine years until 2002. For the next 10 years he served as

pastor of two parishes in the Archdiocese of Philadelphia. In 1998, Father Pérez was named Chaplain to His Holiness Pope John Paul II with the title of "monsignor." He was made a prelate of honor in 2009. On June 8, 2012, Pope Benedict XVI named Msgr. Pérez an auxiliary bishop for the Diocese of Rockville Centre, where he was ordained as bishop in Saint Agnes Cathedral on July 25, 2012.

Most Reverend Mario Eduardo Dorsonville-Rodríguez, Auxiliary Bishop, Washington, D.C.



Bishop Mario Dorsonville was born October 31, 1960 in Bogotá, Colombia. He attended the major seminary of the Archdiocese of Bogotá, where he was ordained to the priesthood on November 23. 1985. He received a licentiate in sacred theology from the Pontificia Universidad Javeriana de Bogotá in 1991 and a doctorate in ministry from The Catholic University of America in 1995. From 1995 -1996 Fr. Dorsonville returned to Colombia to serve as chaplain and professor of ethics at the National University of Colombia and professor of pastoral counseling and catechesis at the major seminary of the Archdiocese of Bogotá. In 1996,

he returned to the United States, serving parishes in the Diocese of Arlington and Archdiocese of Washington for the next nine years. In 2005, Fr. Dorsonville began service as vice president for mission of Catholic Charities of Washington and Director of the Spanish Catholic Center. He was ordained as bishop on April 20, 2015.

In Laudato Si' the Holy Father reminds us that we must hear both the cry of the earth and the cry of the poor. Few can claim to have heard the cry of the poor more clearly than the Vincentians. Yet after much discernment, the Society of St. Vincent de Paul recently determined that they must address the poor in their midst as well. In 2014, President Sheila Gilbert wrote to leaders of the Society saying "I urge you and your board to study the wages your employees need to be self-sufficient and, if you are not yet providing a self-sufficient wage, to develop a timetable to get to that level." This courageous action was also a difficult one, entailing many practical challenges. In this workshop, we invite members of other Catholic organizations to learn from leaders of the Society of St. Vincent de Paul about their experience moving toward just wages, and learn about some other Catholic institutions that have taken similar actions.

Meghan Clark, Ph.D, Assistant Professor of Theology and Religious Studies, St. John's University

Dr. Clark is author of *The Vision of Catholic Social Thought: the Virtue of Solidarity and the Praxis of Human Rights* (Fortress Press, 2014), which won the 2015 Catholic Press Association Book Award in Catholic Social Teaching. She received a Doctor of Philosophy (2009) in Theological Ethics from Boston College. Dr. Clark joined the faculty at St. John's University as an assistant professor of moral theology in 2011. In 2013, Dr. Clark was ap-



pointed as a Fellow of the Institute of Policy Research and Catholic Studies at Catholic University of America in Washington, DC. From 2010-2013, she served as a Consultant to the United States Conference of Catholic Bishops Committee for Domestic Justice. Currently, she serves as a faculty expert for the Holy See's Mission to the United Nations coordinated by St. John's Vincentian Center for Church and Society. In addition, she is on the Board of Directors of America Media and the faculty advisory board for Catholic Relief Services "CRS University" Global Solidarity Network. In 2015, she was a Fulbright Scholar at Hekima Institute for Peace Studies and International Relations at Hekima University College in Nairobi, Kenya.

Reflections: Ms. Vicki Schieber is Education Coordinator at the Catholic Mobilizing Network. Her daughter Shannon, a bright and caring 23-year-old graduate student on a full scholarship at the University of Pennsylvania, was raped and murdered on May 7, 1998. Since this tragic loss, Vicki and her husband, Sylvester, have worked tirelessly to advocate against the death penalty and educate others about the Church's social teaching on the sanctity of life. Her story has touched the heart of thousands through her visits to schools and universities, testimony in state legislatures, and published writings. Vicki is co-editor of Where Justice and Mercy Meet: Catholic Opposition to the Death Penalty, a comprehensively exploration of the Catholic stance against capital punishment.





Why D.C.?

- Our Church is committed to dialogue with civil society, including the political leadership of nations. Both as citizens and as Catholics we gather at our nation's Capitol to raise with national legislators our Church's concerns for people in harm's way.
- Washington D.C. is the base for many civil experts in current domestic and international affairs. D.C. is also the base for large numbers of Catholic leaders in areas such as economic and environmental policy and peace initiatives. CSMG draws on all of these resources and many more to form Catholic leaders for social ministry and advocacy.

Why January?

- ♦ Advocacy with Congress in January or February presents a strategic opportunity, often occurring at the beginning of a new Presidential administration or at the beginning of a new session of Congress. We make every effort to choose dates that fall after the President's State of the Union address and before Congress' first recess of the year for the President's Day weekend.
- Winter is the most affordable season to host a large gathering of Catholic leaders in D.C. at a time when our advocacy can have the most impact on members of Congress and new legislation. Hotel rates are substantially higher from Spring through Fall, and we are committed to keeping the cost of the Gathering as reasonable as possible.

Why a Big Hotel and Conference Center?

- The requirements of hosting more than 500 leaders for four days of meetings in Washington, D.C. during the Winter mean there are no real alternatives to locating the Gathering at a major hotel. Colleges and universities only offer conference services and accommodation during the summer, when our advocacy visits to Congress would be much less effective.
- ♦ The United States Conference of Catholic Bishops has tax-exempt status only in Washington, D.C. and Maryland. Choosing a hotel outside of these locations at which to host CSMG would significantly increase the cost of the meeting and would result in higher registration rates.
- We make every effort to select a hotel consistent with our mission, our commitment to a just and living wage for employees, and in keeping with Catholic teaching concerning labor practices. Unlike many D.C. hotels, the Omni allows employees to organize in unions.
- ♦ Choosing a hotel close to D.C. with easy access to Metro aids transportation and the effectiveness of advocacy with Congress.
- Conferences like CSMG involve extensive contracts with hotels that include commitments to minimum expenditures on meals, minimum rooms filled, etc. By staying at our conference hotel, you support the ongoing success of CSMG.
- We offer the option to arrange room-sharing through on-line registration to make accommodation at the conference hotel as affordable as possible. Good stewardship of the investment in traveling to the Gathering means basing ourselves in a location where we can make the most of opportunities to pray, meet, and plan together, and to reach out to members of Congress.

Why Start on Saturday?

◆ Last year we moved our opening day from Sunday to Saturday (and closing from Wednesday to Tuesday). We did so because the fastest growing number of CSMG participants are emerging or informal leaders, for whom weekend meetings reduce days of missed work or classes. CSMG connects official Catholic leaders with emerging and informal leaders for mission together.


