

Please describe any successes or lessons learned by your Catholic Charities agency related to the Synod on Synodality?

- Strong need for Mental Health Awareness training in communities providing that now. (Green Bay)
- Simply being a part of the diocesan synod process has been great for us and for the
 others on the committee as we are able to add knowledge and expertise about those
 living on the margins. We will also be bringing in other community partners that have
 experience working with several different under-served populations. (West
 Tennessee)
- I worked on the Diocese committee to develop a survey that can be used to kick off listening sessions, if that is what the parishes and groups choose to do. The survey was divided into three parts, Catholics, non Catholics and people in crisis. (East Tennessee)
- Collaboration with Parishes (Western Washington)



Please describe any successes or lessons learned by your Catholic Charities agency related to the Synod on Synodality?

We have felt it is preferable to have marginalized populations join the regular parish listening sessions, so that members of the community can see 'this type of person lives in/this set of experiences takes place in my community.' Given that some marginalized populations will simply not ever feel comfortable in that kind of a parish setting, we are hosting 'focus groups,' to try to reach them, and hear their voice. If others take a similar approach, we would encourage them to filter those marginalized voices back to the parishes/pastors, so they can gain a sense for the breadth of experiences and life stories in their community (and how the Holy Spirit speaks through that breadth of experiences). Please describe any challenges faced by your Catholic Charities agency in promoting the Synod on Synodality.

Reaching out to staff who have fallen away from the Catholic Church. We see a need for sensitive and inclusive language

Timing - entire process is very fast between seeking/inviting input to final report

The direction the commission was given by our bishop is that we may not segregate groups for input.... they must attend one of the listening sessions in the designated parish in their area.

The time frame has been a challenge which has required that we get over perfectionism and have the courage to enter a process which is messy and not completely under control! There has also been a challenge of knowing where to even find some marginalized populations, so that we can invite them. This is telling of how well we are currently doing at reaching out to them

The majority of our staff is not Catholic and are not religious so engaging them on a spiritual level may be a challenge

Our plan was to take the survey out at events that outreach and get feedback. We had an arson fire so we have been limited on reaching the population in crisis because of our fire crisis

I think the biggest challenge is, first, in reaching out to all people and, second, is then in listening to all voices

lack of full guidance from archdiocese on process for listening sessions, slow roll-out

Narrowing down the many areas of broad listening including: many cultures, ecumenical, disabilities, mental health needs, prison, poor, homeless, refugees, young adult, etc

Trying to include the margins is a far-reaching prospect

Our Diocese is sending out a survey to gather information from parishioners and non-parishioners across our Diocese. Our next step is to hold focus groups and CC's role may be to assist in bringing together some vulnerable populations that were not able to participate in the survey. The survey asks each parish how they serve the poor and if they welcome immigrants, this was to support the mission of Catholic Charities. (Dubuque)

We were pleased that our bishop specifically asked us to be included, recognizing that our goal is to reach and touch those who are marginalized. (Covington)

We have decided to continue to integrate Synodality in all that we do, including listening one on one, small group and large group. (Green Bay)

We were very happy that our bishop asked our CC agency to have an active role on the diocese synod committee. That way, we have been able assist in all aspects of the planning and will be active in executing the process. Both Kelley and myself will also serve as facilitators. We believe it would benefit all the participating diocese to have a representative from their Catholic Charities (if they have one) as part of their synod process. (West Tennessee)



BALTIMORE They have trained facilitators and have tweaked the questions suggested in the official Vatican documents. The Catholic Charities agency is hosting 6 listening sessions with agency staff and board, and also different client groups. Listening sessions will be conducted in January.

LANSING Catholic Charities has a representative on the diocesan synodal planning team. They are identifying groups to reach out to, such as Hispanic communities and persons experiencing homelessness and addiction struggles. Susan is diocesan director of Hispanic ministries and the diocese and agency are developing plans to engage Hispanic communities.

CLEVELAND The Cleveland Synodal process has two tracks: 1) parishlevel and 2) trained facilitators who will go to Catholic Charities service centers, such as homeless shelters and food distribution sites. There is concern that many communities on the margins will not be reached.



WILMINGTON – Wilmington has developed a booklet with questions, guidelines, and rules for conduct at listening sessions. The Catholic Charities staff has gone through it, and the board will do so soon. Plans are to engage a residential maternity home and a homeless shelter. Concern: how might they engage those 70,000+ clients struggling with mental health issues and food insecurity and who benefit from an annual agency energy program. Maybe the website?

SEATTLE - Agency is working with the diocesan Office for Mission Effectiveness and Planning. Five Catholic Charities staff are trained as listening session leaders. There will be listening sessions with staff and clients. They are working with deaneries to assist parishes without trained listening session leaders, and which wish specifically to engage those on the margins.
